ESSAY QUESTION (20 minutes)

Willy Witan agreed to drive his law school roommate to the airport after their last class before spring break. As they approached the San Antonio airport, Willy noticed a new sign posted in the "Departures" lane: "WARNING: All cars entering this lane are subject to random search." Up ahead, he could see airport police officers stopping cars, so Willy pulled out of the lane in an effort to pull into the short-term parking garage. An officer saw him and signaled for Willy to stop. When he did so, the officer demanded identification and asked, "Why were you trying to avoid me, sir?" Willy explained that he was in a bit of a hurry because his roommate's flight to Cancun was leaving shortly, but the officer seemed unimpressed. He told Willy he would need to check his car and asked if Willy could open the trunk. Willy handed his key to the officer, who opened the trunk and found (what else?) a brown paper bag. When the officer looked inside the bag, he found a very small quantity of marijuana and some cigarette papers. The officer then asked Willy to put his hands on the car. Willy said, "Look, officer, I'm a law student. They won't let me take the bar if I have a conviction. Can't you cut me some slack?" The officer replied, "Sure. How about if I leave a little slack in these handcuffs?" Willy was cuffed and placed in the back of the patrol car while another officer searched the passenger compartment of Willy's car. In the locked glove compartment, the officer found a switchblade knife marked "Souvenir of Matamoras." He also found a current registration form confirming that Willy was enrolled at St. Mary's Law School, just as he had said.
